Formed in 1994, the Carleton Place & District Memorial Hospital (CPDMH) Foundation was established to raise funds to strengthen the hospital's ability to provide the best healthcare possible to the residents of Carleton Place and surrounding communities.

The CPDMH Foundation is a registered charity, led by a strong, active and dedicated volunteer Board of Directors drawn from across the communities we serve.

OUR TEAM

Every day, our team of caring staff, volunteers and doctors at Carleton Place & District Memorial Hospital touch the lives of thousands of patients and their families with their compassion, skill and expertise.

Our hospital is a 22-bed acute care facility providing emergency care 24 hours a day, 7 days a week, as well as outpatient clinics, physiotherapy and diagnostic imaging services. Last year, 44,670 patients came through our door.

It is thanks to **GENEROUS DONORS** like you, who give back to the health of your community, that we are able to provide the best medical equipment and care to our families, neighbours and loved ones.

In the 2018-2019 fiscal year, support from our donors purchased \$424,009 in much-needed patient care equipment for our hospital. This coming year, another \$487,000 is required — all for equipment which is not otherwise funded through the Ministry of Health and Long Term Care or other sources. Every single item of patient care equipment at the hospital is vital to the care we provide and we are so very grateful and appreciative of each and every donation made in support of your local community hospital!
